OTHER CUSTOMER FEES AND CHARGES

Past Due Fees

For customer who haven't paid their bill by the 15th of the month, a **10% Late Fee** will be assessed on the Water Charges and added to the bill. Past Due/Disconnect Notices will be sent after this fee is added to the bill. Any bill not paid by the 1st of the following month will be Disconnected for Non-payment.

Reconnect Fee (after disconnection for non-payment)

Past Due Bill + \$50

Master Metered Accounts Will Be Billed as follows:

Monthly minimum = \$21.77 x Number of Living Units

Allowed gallons w/minimum = 1000 x Number of Living Units

To Re-Establish Service for Meters Previously Removed From Service

In order to re-establish service for meters which have been previously removed from service to suspend having the monthly minimum charge, a fee equal to the lesser of the two following will be charged. Either the number of inactive months times the current minimum charge or the current Connection Fee (based on meter size), whichever fee is less will be the amount due and paid before reconnection is established. In addition, the appropriate Security Deposit for the meter size must be re-established prior to service being reconnected.
